THE GRAND JURY OF THE COUNTY OF NEW YORK, by this indictment, accuses the defendants YOHENRY BRITO, DARWIN ANDRES GOMEZ-IZQUIEL, YORMAN REVERON, KELVIN SERVITA AROCHA, **INDICTED CO-DEFENDANT 1** and **INDICTED CO-DEFENDANT 2**, of the crime of **ASSAULT IN THE SECOND DEGREE**, in violation of Penal Law §120.05(3), committed as follows:

The defendants, in the County of New York, on or about January 27, 2024, with intent to prevent Lieutenant Ben Kurian from performing a lawful duty, caused physical injury to Lieutenant Ben Kurian.

SECOND COUNT:

AND THE GRAND JURY AFORESAID, by this indictment, further accuses the defendants YOHENRY BRITO, DARWIN ANDRES GOMEZ-IZQUIEL, YORMAN REVERON, KELVIN SERVITA AROCHA, **INDICTED CO-DEFENDANT 1** and **INDICTED CO-DEFENDANT 2**, of the crime of **ASSAULT IN THE SECOND DEGREE**, in violation of Penal Law §120.05(3), committed as follows:

The defendants, in the County of New York, on or about January 27, 2024, with intent to prevent Police Officer Zunxu Tian from performing a lawful duty, caused physical injury to Police Officer Zunxu Tian.

THIRD COUNT:

AND THE GRAND JURY AFORESAID, by this indictment, further accuses the defendants, **INDICTED CO-DEFENDANT 1** and WILSON JUAREZ, of the crime of **TAMPERING WITH PHYSICAL EVIDENCE**, in violation of Penal Law §215.40(2), committed as follows:

The defendants, in the County of New York, on or about January 27, 2024, believing that certain physical evidence, to wit, a red, white and blue FILA sweatshirt, was about to be produced and used in an official proceeding, and a prospective official proceeding, and intending to prevent such production and use, suppressed it by any act of concealment, alteration and destruction.

FOURTH COUNT:

AND THE GRAND JURY AFORESAID, by this indictment, further accuses the defendant, **INDICTED CO-DEFENDANT 2** of the crime of **TAMPERING WITH PHYSICAL EVIDENCE**, in violation of Penal Law §215.40(2), committed as follows:

The defendant, in the County of New York, on or about January 27, 2024, believing that certain physical evidence, to wit, a red Adidas sweatshirt, was about to be produced and used in an official proceeding, and a prospective official proceeding, and intending to prevent such production and use, suppressed it by any act of concealment, alteration and destruction.

FIFTH COUNT:

AND THE GRAND JURY AFORESAID, by this indictment, further accuses the defendant YOHENRY BRITO, of the crime of **TAMPERING WITH PHYSICAL EVIDENCE**, in violation of Penal Law §215.40(2), committed as follows:

The defendant, in the County of New York, on or about January 27, 2024, believing that certain physical evidence, to wit, a yellow jacket, was about to be produced and used in an official proceeding, and a prospective official proceeding, and intending to prevent such production and use, suppressed it by any act of concealment, alteration and destruction.

SIXTH COUNT:

AND THE GRAND JURY AFORESAID, by this indictment, further accuses the defendants, YOHENRY BRITO, DARWIN ANDRES GOMEZ-IZQUIEL, YORMAN REVERON, KELVIN SERVITA AROCHA, **INDICTED CO-DEFENDANT 1** and **INDICTED CO-DEFENDANT 2**, of the crime of **OBSTRUCTING GOVERNMENTAL ADMINISTRATION IN THE SECOND DEGREE**, in violation of Penal Law §195.05, committed as follows:

The defendants, in the County of New York, on or about January 27, 2024, intentionally obstructed, impaired and perverted the administration of law and other governmental function and prevented and attempted to prevent a public servant from performing an official function, by means of intimidation, physical force and interference, and by means of any independently unlawful act.

SEVENTH COUNT:

AND THE GRAND JURY AFORESAID, by this indictment, further accuses the defendant, WILSON JUAREZ, of the crime of **HINDERING PROSECUTION IN THE THIRD DEGREE**, in violation of Penal Law §205.55, committed as follows:

The defendant, in the County of New York, on or about January 27, 2024, rendered criminal assistance to a person, to wit, **INDICTED CO-DEFENDANT 1** who committed a felony.

EIGHTH COUNT:

AND THE GRAND JURY AFORESAID, by this indictment, further accuses the defendant, WILSON JUAREZ, of the crime of **HINDERING PROSECUTION IN THE THIRD DEGREE**, in violation of Penal Law §205.55, committed as follows:

The defendant, in the County of New York, on or about January 27, 2024, rendered criminal assistance to a person, to wit, YOHENRY BRITO, who committed a felony.

NINTH COUNT:

AND THE GRAND JURY AFORESAID, by this indictment, further accuses the defendant, **INDICTED CO-DEFENDANT 2**, of the crime of **HINDERING PROSECUTION IN THE THIRD DEGREE**, in violation of Penal Law §205.55, committed as follows:

The defendant, in the County of New York, on or about January 27, 2024, rendered criminal assistance to a person, to wit, an individual wearing a red Adidas sweatshirt, who committed a felony.
